Supervisor Hamerlinck asked the Governing Board to amend the current Region 28-E agreement regarding appointing a designee in an absence for voting purposes. Discussion was held. A letter will be sent to Clinton County stating that the Board is not inclined to change the 28-E agreement at this time.

Bopes reviewed the recommendations for appointment to the Regional Advisory Committee; these members will be appointed for a two-year term to begin 7-1-15. Discussion was held. Moved by Kelly, seconded by Earnhardt to approve recommended appointments. All ayes.

Bopes discussed the Mental Health Advocate position. The hiring process will begin to fill the upcoming vacancy. Discussion was held.

Bopes gave an update on Managed Care for Medicaid. Eleven bids were submitted to DHS. An announcement of the 2-4 MCOs should be in late July or early August. Discussion was held.

Bopes presented a report from Lori Elam regarding Legislative updates. SF505 is before the Governor to sign. Discussion was held.

CEO Report: Bopes reviewed the report. The Mental Health First Aid Train the Trainer was cancelled. Lori has her name on a list to reschedule and will participate. Discussion was held.
