### **Introduction**

The Eastern Iowa MHDS Region, hereafter referred to as the EI Region, was formed under Iowa Code Chapter 28E to create a Mental Health and Disability Service Region in compliance with Iowa Code 331.390.

The EI Region provides coordination and financial support for mental health and disability services on behalf of individuals located in Cedar, Clinton, Jackson, Muscatine and Scott counties. The population total for the Region is 300,789 according to the 2018 census.

In compliance with IAC 441-25, the EI Regional Management Plan includes three parts: Annual Service and Budget Plan, Policies and Procedures Manual, and the Annual Report. All reports are available on the Region's and the Department of Human Services (DHS) websites:

The Annual Report includes documentation of the status of service development, services actually provided, individuals served, designated intensive mental health services, a financial statement including revenues, expenditures and levies and specific regional outcomes for the year.

This is the seventh year for submitting an Annual Report as a Region. The challenges of operating as a Region continue to be a journey in learning and discovery for all those responsible for successfully implementing the redesign of the county mental health system as envisioned under SF2315.

### Explanations of the charts for three (3) Chart of Account (COA) Codes for the EI Region


In the EI Region, the crisis system is funded under a block grant methodology that is awarded to help fund specific programs. Because of this current method of allocation for FY 21, the number of "Unduplicated Count" on Table B <u>Individuals by Age and Diagnostic Category</u> for several of the Chart of Account (COA) Codes does not have data that accurately reflects the number of individuals actually served. Explanations of the data and charts, which are included below, are described and analyzed for trends relating to usage and actual numbers served:

- 1) COA 44310- Crisis Evaluation
- 2) COA 44313- Crisis Stabilization Residential Service (CSRS)
- 3) COA 45366- Peer Family Support Peer Support Services
  - a) Chart A
  - b) Chart B

### 1). Chart of Accounts (COA) 44301 "Crisis Evaluation" Explanation:

The Region Crisis System has telehealth services embedded into seven (7) emergency departments located within our Region. Emergency Departments (ED's) have the equipment and training so they can access a Licensed Mental Health Professional twenty-four hours per day, seven days per week. A Licensed Mental Health Professional is available via telehealth to assess the individual and provide that information to the treating ED physician. If the ED physician agrees with the recommendation of the telehealth assessment, believes they are safe to discharge *and* if the individual agrees to further assistance, a "hand off" is made by an ED Care Coordinator, also known as the "pitcher", to an EI Region Community Based Care Coordinator, known as the "catcher", in order to assist with services post discharge.

The data chart below show actual numbers of *duplicated* individuals per month served under Crisis Evaluations for a total YTD served of 1212 individuals. This data is pulled from Electronic Medical Records and Care Coordinator metric sheets provided by the EI Region Crisis System. The chart provides data for telehealth and in particular, comparison data provided for the fiscal year of 2020 and 2021.




### 2). Chart of Accounts (COA) 44313 "Crisis Stabilization Residential Service (CSRS)" Explanation:

As stated above, in the EI Region, our crisis system was funded under a block grant methodology. Because of this method of allocation, the number of "Unduplicated Count" of Individuals by Age and Diagnostic Category for COA Code 44313, Crisis Stabilization Residential Service, does not have data that accurately reflects the number of individuals actually served.

Crisis Stabilization Residential Services are provided by Vera French Community Mental Health Center and are available to provide a short term stay for stabilization that are less than five (5) days for residents within the five (5) counties. It provides an alternative to hospitalization that creates another time and space for further evaluation and linkage to services within the EI Region Crisis System.

In analyzing the data in the table below, the EI Region recognized usage was low for FY 21 however, this was due to the COVID surge even though the Crisis Stabilization Residential remained open for admissions.

The data chart below shows actual numbers of *duplicated* individuals served under Crisis Stabilization Residential Service. This data is pulled from the EI Region Crisis System Care Coordinator metric sheets and provides additional data for the fiscal year of 2021 not captured in the Table B.




### 3a). Chart of Accounts (COA) 45366 "Peer Family Support - Peer Support Services" Explanation:

Even though Peer-Family Support Services are not considered traditional "Crisis Services", these are services that are managed under the same contract with the Robert Young Center, the provider that oversees the EI Region Crisis System. Because of the Block Grant methodology of allocation, the number of "Unduplicated Count" of Individuals by Age and Diagnostic Category for COA Code 45366, Peer-Family Support Services, as stated previously on Table B, does not have data that accurately reflects the number of individuals actually served.

Rhonda's House: Respite Services provided by Life Connections, Iowa's first Peer Run Respite Home which is located at 1131 Hospital Drive in Dewitt, Iowa, offers a brief respite for adults experiencing a mental health crisis. As with the Crisis Stabilization Residential Services chart located above, duplicated data collected for Rhonda's House admissions during the winter months decreased in response to the pandemic.

A Peer Respite Support Line was also provided by staff at Rhonda's House beginning in 7/2020 through 3/26/2021 in order to provide an additional method of support to adults experiencing a mental health crisis. Discontinued to avoid duplication as one was already available State wide.






### 3b). Chart of Accounts (COA) 45366 "Peer Family Support - Peer Support Services" Explanation:

Muscatine Community Social Action (MCSA) and Life Connections Wellness Center, as part of the EI Region's Crisis continuum of care, provided Peer Recovery services and supports within the Region to individuals experiencing mental health and substance abuse addiction issues.

The data chart below show actual numbers of *duplicated* individuals served under the COA Code on Peer-Family Support Services including a virtual support option. This data is pulled from the EI Region Crisis System metric sheets and provides more thorough data for the fiscal year of 2021 that was not captured in Table B.





### B. Regionally Designated Intensive Mental Health Services

1) The EI Region has designated the following providers, under an MOU with the MH/DS of the East Central (EC) Region, as an **Access Center** which has met the following requirements:

- Immediate intake assessment and screening that includes but is not limited to mental and physical conditions, suicide risk, brain injury, and substance use.
- Comprehensive person-centered mental health assessments by appropriately licensed or credentialed professionals.
- Comprehensive person-centered substance use disorder assessments by appropriately licensed or credentialed professional.
- Peer support services.
- Mental health treatment.
- Substance abuse treatment.
- Physical health services.
- Care coordination.
- Service navigation and linkage to needed services.

The University of Iowa ACT Team, which traditionally has served the residents of Cedar County, has been evaluated for program fidelity, according to the MH/DS of the East Central (EC) Region's documentation of their most recent fidelity score.

- **4)** The EI Region has *not yet* designated an *Intensive Residential Service* provider that meet the requirements in IAC 441-25.6(8) for access to the residents of the EI Region but plans to sign an MOU with another Region when this service is implemented:
  - Enrolled as an HCBS 1915(i) habilitation or an HCBS 1915(c) intellectual disability waiver supported community living provider.
  - Provide staffing 24 hours a day, 7 days a week, 365 days a year.
  - Maintain staffing ratio of one staff to every two and on-half residents.
  - Ensure that all staff have the minimum qualifications required.
  - Provider coordination with the individual's clinical mental health and physical health treatment, and other services and support.
  - Provide clinical oversight by a mental health professional
  - Have a written cooperative agreement with an outpatient provider.
  - Be licensed as a substance abuse treatment program or have a written cooperative agreement.
  - Accept and service eligible individuals who are court-ordered.
  - Provide services to eligible individuals on a no reject, no eject basis.
  - Serve no more than five individuals at a site.
  - Be located in a neighborhood setting to maximize community integration and natural supports.
  - Demonstrate specialization in serving individuals with an SPMI or multi-occurring conditions and serve individuals with similar conditions in the same site.






The Chart 4 above, while not depicting financial data, reflects the work the EI Region Crisis System has put in place to expand Mobile Crisis Outreach, provided by Foundation 2, to all five (5) counties within the Region.

According to data compiled on behalf of the EI Region Crisis System metrics, 698 calls were made and responded to on behalf of individuals over the age of 18 and 51 calls were made and responded to on behalf of individuals below the age of 18. The EI Region Metric sheets accounted for an actual total of 754 responses however the ages of 5 individuals calling and receiving this service are considered individuals of an unknown age so unable to report on whether the individuals were below or above the age of 18. Face to face response was suspended due to COVID-19

mitigation and concerns during the time frame of 11/1/2020 to 12/15/2020 however, the Mobile Crisis Outreach team remained available to respond via phone.

Cost to the Region for this service was \$578,260 per the Expenditure Table C, which extrapolates into \$767 per response. However, the EI Region believes the Mobile Crisis Outreach is not only the foundation of a continuum of care for the residents of the Region, but is associated with a cost savings for transfers and admissions by law enforcement and hospitals. Law enforcement's time and mileage is lessened, potential ambulance transports are reduced and the costs of an average length of stay at a hospital are figured in as a cost savings to tax payers.

# D. Status of Service Development in FY21

### Crisis Planning Update

The Region's total population is 300,789. It is comprised of three (3) urban (per IAC 25.1) counties- Clinton, Muscatine and Scott, and two (2) rural counties- Cedar and Jackson. This resulted in a broad range of resources and providers, and areas where there is a gap in service providers. One (1) of the most notable examples is that Cedar County does not have a hospital located in the county. This was an important fact when discussing implementation of basic crisis response services throughout the Region.

The Region signed an Agreement for Crisis Services with the Robert Young Center (RYC) on January 14, 2016 to develop a full continuum of Mental Health Crisis Services across the Region that are locally delivered and regionally managed to meet state wide standards.

The Crisis System for the EI Region has been built on foundational components that were established using an incremental approach. It is the intention of the EI Region's Crisis System to ensure crisis services are available and accessible to all residents of the five (5) counties. Crisis services for individuals, including those at risk of entering/reentering either the criminal justice system or admissions to a hospital, were also implemented to deflect from more costly services.

Much of the prevention, response, and resolution of crisis' are handled through services and supports individuals receive such as:

- The Region's Crisis Line, which may be accessed toll free at 1-844-430-0375, rolls up to a 24-hour crisis phone line through *Your Life Iowa*, and is answered by the staff at Foundation2.
- ➤ The Mobile Crisis Response Team provided by Foundation 2 is another option that is specifically designed to deal with mental health crises that are identified by law enforcement or other agencies and can be dealt with through therapeutic intervention rather than a criminal justice intervention. The Mobile Crisis Response Team is currently available throughout the Region and serves both Adults and Children. Individuals may access the Response Team by calling toll free: 1-844-430-0375.
- ➤ The Region is currently partnering with the Robert Young Center Clinicians to provide Telehealth Assessment Services (Crisis Evaluations) in all seven (7) hospitals in the Region for committal and emergency prescreening assistance along with stabilization and resource/referral. The Telehealth Assessment Services (Crisis Evaluations) are available to both Adults and Children.

- Respite Services provided by Life Connections, Iowa's first Peer Run Respite Home which is located at 1131 Hospital Drive in Dewitt, Iowa that offers a brief respite for adults experiencing a mental health crisis. Individuals may call 563-659-1171 to access the service.
- ➤ Crisis Stabilization Residential Services provided by Vera French Community Mental Health Center are available to provide a short term stay for stabilization, less than five (5) days, providing an alternative to hospitalization. It creates another time and space for further evaluation and linkage to services. This service is available to all residents of the Region and located at 2357 W 11<sup>th</sup> St in Davenport, Iowa and serves Adults only. Individuals may access this service by calling 563-396-3017.

On 7/1/2020, the Region entered into a 7<sup>th</sup> Amendment to the Regional Mental Health Services Agreement. Included in this Agreement were services outlined below:

- 24/7 Emergency Department Telehealth Assessment Services (*Crisis Evaluations*) are operational within seven (7) Emergency Departments in the Region. Telehealth is linked to the Robert Young Center's Crisis Stabilization Unit in Rock Island, Illinois and access is available to a Qualified Mental Health Professional (QMHP) to assess the individual in order to recommend an appropriate level of care.
- Care Coordinator Positions, referred to as the "Pitchers" because they "pitch" to outside agencies, are embedded within the local hospitals Emergency Department's (ED) to assist with care coordination within the ED and link individuals with services post-discharge.
- Community Care Coordinator Positions in the Region are referred to as "Catchers" because they "catch" the referral from the ED Care Coordinators and also from a variety of other sources. The catcher staff position is available to assist with post discharge from the Emergency Department or, an inpatient hospital stay, jail, or a variety of other sources.
- Justice Involved Care Coordinator is a Licensed Position Staff who is able to offer Civil Commitment Mobile Pre-Screens and Mental Health Service Re-Connection to inmates in County jails.
- Co-Occurring Care Coordinator Staff are embedded within local substance abuse providers within
  the Region. The staff is able to complete an assessment, known as the American Society of Addiction
  Medicine-ASAM in order to determine appropriate level of care as it pertains to Substance Abuse
  treatment.
- Peer Support Services including Peer Recovery Specialists and Drop-In Centers.
- A Peer-run respite home.
- A Pilot Project Liaison with Law Enforcement.
- Workforce Development and Trainings.
- Mobile Crisis Outreach.
- Crisis Stabilization Residential Services for Adults.

### E. Outcomes/Regional Accomplishments in FY21

### A. The EI Region Children's System Development:

During FY 21, the EI Region struggled with long term financial stability in terms of implementing the Children's Behavioral Health System. Once SF 619 was passed in May of 2021, the Governing Board of the EI Region allocated funds for the Children's Behavioral Health Coordinator position under the 9<sup>th</sup> Amendment to the Regional Mental Health Crisis Services Agreement.

### B. Enhancement of the EI Region's Website:

The EI Region worked with the original website developer to make enhancements to improve end-user experiences. The website redesign also ensured the Crisis Hotline phone number was easily and readily accessible to viewers.


### C. The Coronavirus Aid, Relief and Economic Security (CARES) Act:

The EI Region received funds in relation to the CARES Act in August of 2020 in the amount of \$2,859,079.67. Funds were provided to 19 school districts in the amount of \$1,005,887.74 and 29 providers received \$1,825,479.78. The process of distribution of the funds resulted in four (4) rounds of RFP's being issued with the focus on providing a variety of resources to ensure safety and wellbeing of staff, children and adults within the Region. The final determination for funding was made by the Governing Board in all four (4) rounds. Total expended was \$2,831,367.52


### D. Pilot Project for a Law Enforcement Liaison Position:

A pilot project was initiated in FY 21 to determine the need to assist law enforcement in responding to mental health calls. The City of Clinton Police Department had fully embraced the concept and served as the test site. The EI Region Crisis System utilized staff employed under the Crisis System contract. Behavioral Health staff were available on a limited basis to the City of Clinton Police Department and participated weekly in "ride along" to assist with calls related to mental health concerns. Trainings were also provided to the Law Enforcement, Fire Department, EMS and Dispatch Center for staff to assess calls for the use of mobile crisis response.
